The ARCS Foundation Atlanta Chapter's Scholar Awards Luncheon on November 14 will present a total of \$285,000 in awards to 40 outstanding scholars from Emory University, Georgia Institute of Technology, Morehouse College and the University of Georgia. In the past 20 years, ARCS Foundation Atlanta has given nearly 600 awards amounting to over \$2.5 million dollars.

Keynote Speaker

Dr. Daniel L. Barrow,

MBNA/Bowman Professor and Chairman of the Department of Neurosurgery and Director of the Emory Stroke Center at Emory University School of Medicine, will discuss health issues and advancements related to his field.

Dr. Barrow received an M.D. degree from Southern Illinois University School of Medicine

and completed a general surgery internship and neurosurgical residency at Emory University Affiliated Hospitals, neurology training at Massachusetts General Hospital and a fellowship in cerebrovascular surgery at the Mayo Clinic. The author of more than 250 scientific articles and chapters in medical textbooks, Dr. Barrow's research interests focus on cerebrovascular disease and

Hilton Hawaiian Village Waikiki Beach Resort Hawaii ARCS Foundation National's Board meeting was held October 3-6, 2012, in Minneapolis, Minnesota. Highlighting the meeting was a panel discussion by members of the Science and Engineering Advisory Council (SEAC), an organization formed in 2009 to assist ARCS Foundation National Board in communicating the goals and mission of the organization to a national constituency. SEAC is composed of distinguished scientists and engineers from across the country and draws on their collective experience in government, industry and academia. The Council provides advice and recommendations on the development of new chapters and assists in implementing strategies for engaging external decision-makers with ARCS Foundation. Rich DeMillo, member Ronnie Martin's husband, serves on the Council.

From the presentation we were reminded that the world today is not what it was in 1958 when ARCS Foundation was founded. At that time the threat was solely the Soviet Union, communications were slower, education values were high and our country trusted science and technology. By contrast in 2012, threats are global, communication is rapid, science and education are under assault and there is public distrust of science and technology.

ARCS Foundation needs to carry the culture of this organization, to be enthusiastic, and be the vehicle that promotes the future of science and technology in this country. All of us need to be fund raisers for our scholars. If a company has a STEM (science, technology, engineering and math) initiative then they should give. Never apologize for asking for money for ARCS Foundation.



"It Takes a Village...."

20th Anniversary Historical Perspective: When Teed Poe asked ARCS Foundation Atlanta's Founding President Mary O'Connor to trace the chapter's history, Mary responded with her "best recollection."

Three charming women from the West Coast, ARCS Foundation National Board Members, arrived in 1990 or 1991 to stimulate interest in starting an Atlanta chapter. Several women were approached, and I was fortunate to be one of them. After a long breakfast meeting, I agreed to fly to the ARCS Foundation National Annual Meeting in Seattle to meet additional members and attend their meetings.



Where to Begin?

My strategy was simple: Gather a diverse group of Atlanta women who have already made community service a priority, through leadership in the arts, garden clubs, social services or through their own professional and corporate connections.

We met on two occasions around my dining room table and agreed that the ARCS program could be of significant value to our colleges, universities and city, and together, we set the following guidelines:

- Programs and venues would be educational in nature;
- Dues would be substantial enough to avoid additional fund-raising activities during the start-up phase, with an initial goal of establishing three scholarships;
- One of our three selected Atlanta institutions would be an African-American college or university.

First 3 Scholarships

The recruitment phase was relatively easy: Each Founding Member chose a list of invitees [potential charter members]. We forged ahead with our 501(c)3 status and held the first orientation meeting at Georgia Tech to set the tone. Twenty years later, the chapter remains strong and healthy. In a very short time, we held our first Scholar Awards Luncheon and awarded three scholarships totaling \$15,000!

As it is often said, "It takes a village to make things happen...". Our chapter is testimony to the Founding Members who shared the ARCS Foundation vision, and were willing to take the challenge to support the Atlanta educational community with additional funding for their superb scholars. KUDOS to all of them!

Speaker -- Gary W. Miller, PhD., Rollins School of Public Health. Dr. Miller is the Associate Dean of Research and Asa Griggs Candler Professor of Environmental Health. Among his many responsibilities, Dr. Miller oversees the doctoral programs of the RSPH and has served as the Director of Graduate Studies for the Department of Environmental Health. In 2011, Emory doctoral students voted Dr. Miller the Mentor of the Year. Dr. Miller serves as Director for Emory's Parkinson's Disease Collaborative Environmental Research Center and directs Emory's Toxicology Training Grant. He is President of the Neurotoxicology Specialty Section of the Society of Toxicology and Associate Editor of Neurotoxicology. He holds a B.S. and M.S. from Old Dominion University and PhD. from the University of Georgia.

Rollins School of Public Health

Founded in 1990, the Rollins School of Public Health is a recognized leader in preventing disease, improving health and teaching students to identify, analyze, and intervene in today's most pressing public health issues. The school's location in Atlanta makes it an ideal setting for hands-on research, collaborations with the world's leading public health agencies, and interdisciplinary work with national and international organizations. Students join the RSPH community from all 50 states and more than 40 foreign countries to contribute to the school and apply knowledge to promote health and prevent disease in human populations. The RSPH comprises six departments with more than 1,000 masters degree students and more than 150 doctoral students. The latter choose from degree options in behavioral sciences and health education, biostatistics and bioinformatics, epidemiology, environmental health, health policy and management, and international nutrition.

The Lawrence P. and Ann Estes Klamon Room

When RSPH's new Claudia Nance Rollins Building opened in the fall of 2010, a 2,720-square foot multipurpose meeting room was named in honor of two "longtime friends" of Emory and RSPH--The Lawrence P. and Ann Estes Klamon Room. The room recognizes the establishment of the James W. Curran Dean of Public Health endowed chair, made possible by the generosity of Emory and the Klamons. Ann, an ARCS Foundation Atlanta member, is a graduate of Emory College and Emory Law School, and she and her husband, Larry, chair the RSPH Campaign Emory Committee.


Advancing Science in America

Celebrating the Past and Looking to the Future

Take a noble mission, a small group of smart, dedicated women and a lot of hard work and what do you get? – The 20th Anniversary of the vibrant Atlanta Chapter of ARCS Foundation. This year is an appropriate time to celebrate the accomplishments of our chapter and its founders and to reflect on how the chapter has grown and succeeded over two decades.

Growth→ . Since 1992, the membership has increased from 16 founding members and 20 charter members to the current 151 active and associate members. During the chapter's first year, members supported three scholars; today, we support 40. Funds required to support awards have grown exponentially from \$15,000 in 1992 to \$285,000 in 2012—the largest amount in our chapter's history.

Change→ Active fund-raising is now responsible for a major part of our scholar awards funding. In the early years, members' dues and several gifts from member-related companies and foundations covered scholar awards. No donations beyond dues were expected from members. This year's awards were made possible, in large part, by the generosity of our members: 65 members gave a total of more than \$150,000 over and above their dues. Almost all of the remaining contributions resulted from members opening doors to individuals, foundations and corporations that donated to the Scholar Awards Fund.



Challenge → Continuing to build on the success of the Atlanta Chapter will require not only financial support from our faithful members, but also outreach to new donors-individuals, foundations and corporations. With our clear mission and working together on a common goal...just think about what we can accomplish in the next 20 years!

New Website a Success for Event Registration

ARCS Foundation Atlanta members recently experienced a new way of registering for chapter events when Sara Jean Burke and Mary Snitch arranged a tour for 40 lucky chapter members to the Lockheed Martin facilities in Marietta.
